RULES & GUIDELINES

- 1. ***<u>All vendors must be on the field by 3:00pm</u>**<u>NO FOOD VENDOR VEHICLES</u> WILL BE ADMITTED ONTO THE EVENT FIELD <u>AFTER 3:00PM</u> NO EXCUSES /NO EXCEPTIONS**NO REFUND WILL BE PROVIDED IF YOU ARE LATE
- 2. All items must be on-site consumable food items. Vendors can sell multiple food items and no entrees are exclusive to any vendor (i.e. multiple vendors can sell the same food item).
- 3. ALL PRICES NEED TO BE CLEARLY DISPLAYED IN BOLD 2" LETTERING.
- 4. Food vendor spaces will be assigned at check-in which begins at 12:30pm.
- 5. Food vendors must have Health Dept. pre-event approval plus Health Dept. event day inspection and ready to serve by 4:00pm. Once inspections are complete, vendor may serve continuously until 9:00pm. Vendors will depart after crowd disperses. Anticipated for 9:15pm or when directed by the Committee.
- 6. Each vendor space is approximately 12'frontage. Food trucks will have some additional space to accommodate their vehicle. Special allowances will be reviewed, if requested in writing, at time of application.
- 7. Vendor units must be self-contained. The event field has no water source or electrical service. A commercial refrigerated trailer will be available to food vendors at no additional cost. Please advise if you wish to utilize.
- 8. A dumpster will be on-site for your cleanup. All vendors will be expected to leave your service area clean at the end of the evening.
- 9. Vendors using gas grills or generators must be equipped with fire extinguishers. In addition, vendors using deep fryers or oil-based cooking methods must have a Class K fire extinguisher.
- 10. Fees: Commercial Food Trucks and Commercial Vendors \$150 non-refundable fee per space.

 Non-profit organization food Vendors \$50 non-refundable fee per space.
 - ***PLEASE NOTE: All checks will be held until after the event. Entry fees will only be processed if the event is held: should both the event date and rain date be cancelled your check will be voided and returned to you.
- 11. You should bring a flashlight or lantern lighting as when the lights are turned off for the fireworks it will be very dark. (you can sell your products during the fireworks show).
- 12. Space is limited. Vendors will be selected on a first come/first served basis. Fees will be returned immediately to those applicants not selected. Final Deadline for applications is Friday, July 26, 2024 and are subject to space availability.
- 13. When we receive your Vendor Application, you will be required to immediately contact Housatonic Valley Health District to get their forms to complete for Health Department compliance. Vendors will be separately responsible payment of any application fees the Health Department may require.

- 15. Attach a copy of your Connecticut Sales Tax Permit with your application.
- 16. The Fire Marshal's Office will conduct event day inspections and may have additional requirements.
