Re: RFP 2025-007 & 2025-008: Library Switching and Wiring Project

Eight bids for the Library Switching and Wiring Project were received on July 16, 2025. Present at the bid opening were Finance Director Dan Colton, Office Manager Noreen Thompson, and IT Director David Richards. Bids were solicited to repair the wiring that had been submerged during flooding as well as to replace core switching, firewall, and Wi-Fi equipment. Bids that included options for extended subscriptions and switching levels were also accepted.

Based on the bids received, it is my recommendation that the award be given to CCi Voice for both RFP 2025-007 and 2025-008.

CCi Voice has successfully worked on projects for the Town in the past and has specified equipment that is compatible with much of the town's existing infrastructure. As with all bids, in the case of non-response or unavailability of the low bidder for a particular project, the Town reserves the right to proceed with the next qualified low bidder.

As part of the bid, the Town agreed to cover the consulting cost to reprogram some of the equipment with the assistance of our MSP for up to 5 hours. (\$750). The winning vendor will be responsible for any additional time needed. The total cost including the selected options for both RFP's will be: \$24,424
