State Announces \$5,000 Grants for Small Businesses & Nonprofits

Am I eligible for a Small Business/Nonprofit Grant?

Governor Lamont announced that the state has created the Connecticut CARES Small Business Grant Program to help small businesses and nonprofits that continue to be negatively impacted by COVID-19.

Small businesses and nonprofits in Connecticut with a 2019 payroll of less than \$1.5 million *or* 20 or fewer employees can apply for a one-time grant of \$5,000. The Department of Economic and Community Development [DECD] will administer the program and online applications are estimated to begin the week of November 9. All funding will be disbursed by the end of the year.

Per Governor Lamont's direction, half of the funds will be allocated to small businesses and nonprofits located in towns and cities that have been designated as distressed municipalities. The program is funded from Connecticut's portion of the federal CARES Act.

DECD will also host webinars and online discussions in the coming weeks to assist businesses and nonprofits with the application process.

State Announces \$5,000+ Grants for Arts Nonprofits

Am I eligible for an Arts Grant?

Governor Ned Lamont also announced that the State of Connecticut will be providing up to \$9 million in grants to certain nonprofit arts organizations in the state to help them recover more quickly from the impact of the ongoing COVID-19 pandemic.

The COVID Relief Funds for the Arts will support (1) Arts nonprofits for whom grants will make a difference in terms of survival or rehiring; and (2) Arts nonprofits that have had to curtail operations for a period of time due to the pandemic and which have had limited ability to reopen due to pandemic restrictions and/or have had to pivot their service delivery due to pandemic restrictions.

Qualifying organizations could receive a base grants of \$5,000. For organizations that have raised funds between March 10 and November 1, 2020, the program will offer a supplemental match of 50 percent of contributed income during that period. The maximum award for any organization is \$750,000.

CT Sector Rules for Phase 3 and Certification for Reopening

Phase 3 Reopen Rules by Sector https://portal.ct.gov/DECD/Content/Coronavirus-Business Recovery/Sector-Rules-and-Certification-for-Reopen

- Indoor private gatherings (e.g. weddings, office meetings, parties) 50% capacity, capped at
 100 people (including front of house staff) Note: Gatherings at private residences are capped at 25
- Outdoor private gatherings (e.g. weddings, reunions, parties) capped at 150 people
- Graduations 50% capacity capped at 200 people with social distancing and masks required.
- Religious gatherings 50% capacity capped at 200 people with social distancing and masks.
- Restaurants 75% capacity indoors with 6 ft spacing and/or non-porous barriers
- Personal Services 75% capacity indoors with 6 ft spacing and/or non-porous barriers
- Libraries 75% capacity indoors
- Outdoor event venues (e.g. Amphitheaters, Race Tracks) 50% capacity with social distancing and masks required Note: If an outdoor event venue is holding a private gathering, they are subject to the 150-person limit under outdoor private gatherings
- Indoor Performing Arts Venues 50% capacity with 6 ft spacing between parties
- Bars and nightclubs will continue to remain closed.
