### Friday, 6/12 Last Day to Request Masks & Thermometers

Friday, 6/12/20, is the last day that small businesses can request free thermometers and face masks under the State's distribution program. 5 p.m. is the cut-off time.

If you have less than 50 employees in your CT-based small business, and you have not already requested your <u>face masks</u> and <u>thermometer</u>, please do so ASAP by clicking the links.

### PHASE 2 of Reopening ~ June 17th

We are excited that the next chapter in reopening Connecticut will occur on June 17<sup>th</sup>. The following businesses will be permitted to reopen:

- All personal services (nail salons, tattoo parlors, etc.)
- Movie theaters, Bowling alleys
- Outdoor arts, entertainment and events up to 50 people.
- Social clubs and pools
- Indoor restaurants, Hotels (but no bars)
- Museums, Zoos
- Outdoor amusement parks
- Public libraries
- Youth sports
- Summer day camps (June 22)
- K-12 summer school (July 6)

Remember that, if you have not yet done so, your business is required to <u>self-certify</u> with the State before you open, to ensure that you are compliant with the <u>industry-specific requirements</u>.
