They will continue to be accepted until 11:59pm PT Sunday, August 23 or until 500 applications have been submitted, whichever is sooner. They expect to hold subsequent grant rounds to accept additional applications later this summer.

In partnership with The Hartford, the grant program will fund solutions that help small brick-and-mortar business owners respond and adapt to the COVID-19 pandemic, and also help to revitalize and strengthen older and historic downtown commercial districts.
